I have resided at 5329 Sandburg Drive in River Park for 34 years; the American River levee is just beyond our back fence. I have enjoyed the fruits of your agency's diligence and have had some informative conversations with your crews as they perform their tasks. I have a lot of faith in your agency.

I urge you to support the City's request to allow the $1 / 4$ mile bike trail on the top of the levee near the Business 80 bridge. I have been a bicycle commuter to my job downtown for over 20 years. In River Park, the treacherous $\mathrm{J} / \mathrm{H} /$ Carlson intersection is hazardous to bicycles and to pedestrians alike, so a safe off-street route to the downtown area would be of great benefit to me and to many others.

Thanks to SMUD's recent tree clearances, for the past 3 weeks I have had a clear view of the levee top from our living area during the evening hours. I see a lot of bicyclists, runners and walkers using top of the levee. (l understand that bicycle riding is technically illegal, but I have never seen it enforced).

Whether or not the portion of the levee under discussion is paved or not, those levees will continue to be heavily used by all walkers, runners, bicycles, and dogs. If it is paved, I would have to ask what specifically is it that impedes the District's work: the people? the bicycles? or the pavement itself? If the issue is the walkers/runners/bicyclists, then there is a simple way to ensure the District's access, and that is to gate off that section of the levee and to have the Rangers started writing citations for off-road bicycle use. If it is the presence of pavement, then the engineering data that shows how its presence degrades the integrity of the levee should be shared.

There are many places in which the top of the levee is paved and is used for a bike trail: between the Fair Oaks/J Street bridge and the Guy West Bridge, along the Sacramento River from Old Sacramento to the Land Park area, and the paved portions on the north bank of the American River between Howe and Watt avenues. Surely there is a wealth of experience from these areas that can be applied to the question at hand.
