Improving the River Park Levee Slope

n the past, some residents whose property is next to the River Park levee obtained permits to install landscaping and vegetation terraces at the bottom of the levee, also known as the levee toe. For some, these features were even permitted on the levee slope. Over time many of these landscape features were not maintained and eventually became overgrown or deteriorated. Many sites became a mysterious lump on the side of the levee or a mound at the levee toe. These encroachments interfere with our ability to mow and traverse the levees on foot. They also limit our ability to inspect the levees and identify new problem areas during a flood event.

KEEPING LEVEES ACCESSIBLE AND SAFE

In an ongoing effort to keep our levees accessible and safe, the American River Flood Control District developed a collaborative project with River Park residents to improve the condition of their levee slope. To maintain a clean and uniform levee slope and a levee toe with clear access for maintenance and flood inspection, in 2008 the District began working with numerous landowners to remove abandoned encroachments. We used a long-reach excavator positioned at the top of the levee to remove deteriorating retaining walls, debris, and mounds of dirt. The result was a clean levee slope free of obstructions that will no longer compromise levee safety. We then restored each site with a grass seed mix and erosion control straw and wattles (a tube of straw used to slow water run-off). With the help of participating landowners, we placed timed watering systems at each site to provide the optimum amount of watering for healthy germination. These sites now have a lush mat of grass to help the slope resist erosion.

REQUESTING SERVICE IN YOUR AREA

This successful effort was a great opportunity to connect with the community and provide information on the importance of uncluttered, well-maintained levees. Numerous residents approached us during the work to ask what we were doing. We are happy to offer these services to anyone expressing interest in seeing a cleaner levee behind his or her home. Based on these contacts, we added numerous sites to the 2008 and 2009 schedule. We welcome the continued support and interest of our neighbors in River Park. Do I Need Flood Insurance?

The Sacramento area has a long history of catastrophic flooding. A system of levees and bypasses keeps high flows contained in the river channel. While this system reduces the risk of flood, there is always a threat of a storm exceeding flood control defense capabilities.

The U.S. Army Corps of Engineers and others have accomplished numerous reconstruction projects to improve our levees. In 2005 after calculating their cummulative effects, the Federal Emergency Management Agency (FEMA) declared many Sacramento area levees able to withstand a 100-year flood. This means that the areas behind the levees have less than a 1 percent (one in 100) chance of being flooded in any given year. As a result of this study, large sections of the Sacramento area were removed from the FEMA 100-year floodplain map and many residents were subsequently released from the federal requirement to carry flood insurance.

Although our Sacramento levees are in better shape than ever, and the U.S. Army Corps of Engineers has projects under way to bring even better flood protection to our region, there is always a chance that a flood will exceed the protection our levees provide. For this reason, we suggest that all of our residents still carry flood insurance.

LOW-COST INSURANCE AVAILABLE

Sacramento property owners who have been released from the federal flood insurance requirement may be eligible for low-cost preferred risk flood insurance. Preferred Risk Policies (PRPs) are guaranteed by the federal government and provide full flood insurance protection for roughly half the price of standard coverage. Partnering With the CCC

e recently had the privilege of working with crews from the Sacramento satellite of the California Conservation Corps to remove difficult vegetation on our levees. Corps members hauled brush and debris up the steep levee slopes. This debris was later chipped and spread as mulch. This cooperative effort demonstrated that CCC supervisors and Corps members have tremendous experience and dedication to a job well done.

From this positive experience, we also learned that the CCC bids competitively on a variety of projects. The CCC strives to develop the job skills of its Corps members and teaches them how to inspect job sites, consider logistical challenges, and calculate the time and resource needs to form a price for a contract bid. Our District requested a bid from the CCC for line-trimming (using weed whackers) at many difficult locations on our levees. At our June 2009 Board of Trustees' meeting, members reviewed the CCC bid and had the opportunity to meet the Corps members who developed it and ask questions about the work and team member roles. The Board awarded the bid to the CCC at that meeting.



We are very pleased that the contract was performed expertly and completed on schedule in July 2009. The work was very thorough and the CCC crews took special care to avoid sensitive species and residents' permitted vegetation. CCC leaders maintained excellent

communication with their crews and with District staff during the contract. It was a pleasure to work with the dedicated members of the CCC and we look forward to a long working relationship with them in the future. Together we will keep Sacramento levees clean and clear.

American River Flood Control District Crew Receive Safety Awards

The Association of California Water Agencies once again recognized the crew of the American River Flood Control District for innovations which improve safety on the job.

Ross Kawamura received the Safety Award for his catwalk modification to our Peterbilt dump truck. His design allows an operator to inspect and remove debris while standing on the catwalk of the dump bed. Also recognized was **Sean O'Connor** for adding access steps to our Peterbilt dump truck to allow easier and safer inspection of the truck bed. **Eric Maculak** identified a possible danger in the operation of our grout trailer and added emergency shut-off switches to protect the operators. **Roger Unruh** modified the system that covers the dump truck bed to alert the driver when the tarp is fully retracted, reducing the possibility of burning out the tarp operation motor.

Each award winner received a check from ACWA for \$100 for his effort to keep the District safe and ultimately protect the community through more efficient work practices. **Our experienced team members are innovative problem solvers and they all continue to look for ways to improve our already outstanding safety record.** Way to go guys.
